Redstone Arsenal Environmental Program Public Comment Period – August 18, 2026-September 17, 2026 Proposed Corrective Measures at RSA-286

The U.S. Army Garrison at Redstone Arsenal is proposing to implement corrective measures at RSA-286, Former Building 3624, Boiler/Steam Plant #3, Operable Unit 24, located in the northeastern portion of Redstone Arsenal. Chemicals of concern (COC) have been identified as arsenic and polycyclic aromatic hydrocarbons (PAHs) in soil and groundwater. The COC concentrations in soil and groundwater pose an unacceptable human health risk.

The preferred corrective measures for soil consist of the following actions:

- Excavation of contaminated soil in nine areas to depths ranging from approximately 2 feet to 6 feet below ground surface, to residential cleanup goals (total estimate of 210 cubic yards)
- Disposal of contaminated soil at an approved facility
- Backfill of excavation with clean soil and restoration of site
- Long-term monitoring for cobalt and naphthalene in groundwater.
- Implementation of land-use controls to prohibit future land use that is not consistent with current use as a closed landfill and restrict intrusive activities at the site that may cause potential exposure to contaminated soil and groundwater.
- Implement groundwater LUCs, as outlined in the groundwater IROD for Redstone Arsenal.

The final corrective measures will be selected only after acceptance by the Alabama Department of Environmental Management and after this public comment period has ended and all comments have been reviewed and considered.
